3. **Chapter 10 Code Language Revision-** draft provided to board by Town's Attorney
4. **McKinley Beach Road-** surveyor is just about done, planning to wrap up next week
5. **Schoenfeld's Woodland Plat-** waiting to hear back from Kartechner Brothers.
6. **Farmland Preservation Zoning-** Tim Jackson from the state gave a brief overview of the program and answered questions from those in attendance.
7. **Yard Waste Dumping Hours-** board discussed opening on Saturdays from 8-2pm during April to November but closed on holiday weekends. Board will announce in tax letter final decision and reiterated the resolution passed in 2022 that the board reserves the right to close when they see fit. Some residents in attendance asked for
