- **1. Update on Shaw Hill Bridge-** board will be putting a proposal together to send to the railroad company.
  - **2. Equipment-** new plow is in Sun Prairie and will take about a year to be built. If we want a second one we need to decide within 30 days and would receive it in 2027. If we wait the price will go up due to cost of emissions. Mower should be updated as well, instead of just renting one each year. Old squad car has been sold for \$4300.
- **3. Town Hall Gate/Fence** due to tax letter having been sent out with dates for 2025 no action will occur until 2026 unless the 2024 issues with illegal dumping continue. Chairman will reach out Heiar Fencing to provide a quote for April's meeting.
